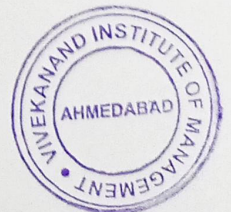
The President/Chairman hereby constitutes a standing committee to be known as Anti ragging committee comprising of the following:
